举办“新生儿生命支持技术高峰论坛”通知

为促进我国新生儿危重病医学的发展以及新生儿生命支持技术的应用与推广,不断提高危重新生儿的抢救水平,《中国当代儿科杂志》编辑部、广州市医学会新生儿科分会、广州市妇女儿童医疗中心(广州市儿童医院)拟于2017年7月27~30日(27日报到,30日上午撤离)在广州联合举办“新生儿生命支持技术高峰论坛”。
